No Candidate or any person serving on a campaign committee for a candidate shall act as agent for any registered voter requesting an early voter's ballot unless such person is a member of the registered voter's family. No person shall act as agent for more than two voters for any one election. The penalty for election falsification is imprisonment for up to five years, or a fine not to exceed \$10,000.00 or both.

**Request by Mail: 4:30 P.M., Friday, October 25, 2024**  
**Request in Person: 4:30 P.M., Monday, November 4, 2024**  
**Request by Agent: 7:00 P.M., Tuesday, November 5, 2024**

*Ballots returned by agent must be returned by 8:00 P.M. on Election Day.*

*Ballots returned by mail must be in the possession of the Election Office by 8:00 P.M. on Election Day.*
