No Candidate or any person serving on a campaign committee for a candidate shall act as agent for any registered voter requesting an early voter's ballot unless such person is a member of the registered voter's family. No person shall act as agent for more than two voters for any one election. The penalty for election falsification is imprisonment for up to five years, or a fine not to exceed \$10,000.00 or both.

Request by Mail: 4:30 P.M., Monday, May 31 2026

Request in Person: 4:30 P.M., Monday, May 11, 2026

Request by Agent: 7:00 P.M., Tuesday, May 12, 2026

Ballots returned by agent must be returned by 8:00 P.M. on Election Day.

Ballots returned by mail must be in the possession of the Election Office by 8:00 P.M. on Election Day.

Nebraska Voter Registration Application forms are available at the Pierce County Clerk's Office during regular business hours. (In person voter registration deadline is May 1st at 6:00 pm)
