COMMISSIONERS PROCEEDINGS December 9, 2024

The Pierce County Board of Commissioners met pursuant to adjournment on Monday, December 9, 2024, at 9:10 A.M. with the following members present: Tom Kuether, Brad Albers and Carl Martinson. Co. Clerk Shannon Wragge, Zoning Adm. Heather McWhorter, Co. Attorney Ted Lohrberg, Hwy Supt. Brian McDonald, Brad Lockee, Laura Lockee and News Reporter Randee Falter were present.

Notice of the meeting was given in advance as shown by the Certificate of Publication on file in the County Clerk's office. Availability of the agenda was communicated in the advance notice of the meeting. All proceedings hereafter shown were taken while the convened meeting was open to the public. Chairman Kuether called the meeting to order at 9:11 A.M. and presided. Chairman Kuether stated that the Open Meetings Act is posted on the north wall of the board room with more copies available at the County Clerk's office.

Motion by Albers, seconded by Martinson, to correct agenda to state <u>Approve Resolution</u> <u>2024-24</u>, upon a sign study by Hwy Supt Brian McDonald he recommends to replace Yield sign with a Stop sign to control the east bound traffic at the intersection of 546 Ave and 849 Rd in Pierce County, NE and to approve the agenda. The minutes of November 25, 2024 were approved as printed.

Zoning Adm. Heather McWhorter was present along with Brad & Laura Lockee whom are requesting to split a subdivision tract on ground located at 54830 850 ½ Rd, Pierce, NE in South Willow Lake 2nd Subdivision, Lot 9 in pt of the NW ¼ 9-25-2. Zoning Board made recommendation to allow and needed approval from county board so Lockee's can begin the survey process.

Motion by Albers, seconded by Martinson, to approve the split on ground located at 54830 850 ¹/₂ Rd, Pierce, NE in South Willow Lake 2nd Subdivision, Lot 9 in pt of the NW ¹/₄ Section 9, Township 25 North, Range 2 West, Pierce County, NE. Roll call vote: Aye: Kuether, Albers and Martinson. Nay: None. Motion carried.

Motion by Albers, seconded by Martinson, to approve the Reappoint Joe Aschoff and Guy Ellsworth to the Zoning Board for a 3-year term – Dec 2024 to December 2027. Roll call vote: Aye: Kuether, Albers and Martinson. Nay: None. Motion carried.

Motion by Albers, seconded by Martinson, to approve the Patent Lot Split in pt of the NE ¹/₄ of Section 10, Township 28 North, Range 1 West, Pierce County, NE. Roll call vote: Aye: Kuether, Albers and Martinson. Nay: None. Motion carried.

Hwy Supt Brian McDonald was present and he updated the Board on the current road and bridge projects and discussed the resolution and his sign study on 546 Ave and 839 Rd.

Hwy Supt. Brian McDonald was present and discussion held on the stop sign resolution, solar roads west of Pierce and bridges that need work done.

Motion by Albers, seconded by Martinson, to approve Resolution #2024-24 as follows: RESOLUTION #2024 - 24

WHEREAS, an engineering study was made of the intersection of County Avenue 546 with 849 Road in Pierce County, Nebraska.

WHEREAS, presently a yield sign controls eastbound traffic and a stop sign controls westbound traffic.

WHEREAS, the findings of the engineering study revealed that obstacles block visibility to the south for both east and westbound vehicles resulting in an unsafe condition. The engineering study also showed that there is not adequate site distance to allow for the use of the existing Yield sign. The study recommended that the yield sign be replaced with a Stop sign to control east bound traffic and that the Stop Sign controlling westbound traffic remain in place at the intersection of County Avenue 546 with 849 Road in Pierce County, Nebraska.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Commissioners of Pierce County, Nebraska, that the eastbound and westbound vehicles be stopped at the intersection of County Avenue 546 with 849 Road, Pierce County Nebraska and that the necessary signs be installed.
