The Pierce County Board of Commissioners met pursuant to adjournment on Tuesday, January 21, 2025, at 9:10 A.M. with the following members present: John Steinkraus, Brad Albers and Carl Martinson. Co. Clerk Shannon Wragge, Co. Attorney Ted Lohrberg, Zoning Adm. Heather McWhorter, Bullet Beaudette, Extension Agent Ann Fenton and News Reporter Randee Falter were present.

Chairman Tom Kuether was no longer a board member therefore a call for Chairman Pro Tem was made for the county board meeting.
