COMMISSIONERS PROCEEDINGS

February 18, 2025

The Pierce County Board of Commissioners met pursuant to adjournment on Tuesday, February 18, 2025, at 9:10 A.M. with the following members present: John Steinkraus, Brad Albers and Carl Martinson. Co. Clerk Shannon Wragge, Deputy Sheriff Jacob Wostrel, Brian Moes, Matt Sorensen, Mandy Backer, Tracy Golden and News Reporter Randee Falter were present.

Notice of the meeting was given in advance as shown by the Certificate of Publication on file in the County Clerk's office. Availability of the agenda was communicated in the advance notice of the meeting. All proceedings hereafter shown were taken while the convened meeting was open to the public. Chairman Martinson called the meeting to order at 9:10 A.M. and presided. Chairman Martinson stated that the Open Meetings Act is posted on the north wall of the board room with more copies available at the County Clerk's office.

Brian Moes was present to visit with the Board about road issues, dangerous intersections and tree removal on county roads. The Board then talked with him about removing his property from the county right-of-way in front of his farm in Plum Grove Township. The Board will look at the areas of problem roads brought to their attention and Moes will see to cleaning up the county right-of-way.

Matt Sorensen, Mandy Backer and Tracy Golden with Northeast Power Public Power District were present to visit with the Board about the construction and the county road maintenance plan for a solar farm north of Osmond. Zoning Board will approve the Conditional Use Permit and will then come before the county board in March 2025. Construction is planned to begin in Summer 2025.

WHEREAS, the County Board of Commissioners for Pierce County serves as the Governing Body for Pierce County, and

WHEREAS, the County of Pierce has a responsibility for providing funds for county burials of indigent individuals, and

WHEREAS, the County of Pierce desires to improve the application process for funds for county burials.

THEREFORE, BE IT RESOLVED by the Pierce County Board of Commissioners:

<u>Section 1:</u> That an Application for County Burial and Financial Affidavit must be completed, signed and notarized by a relative or concerned friend and will be used as a means to help determine whether an individual qualifies for county burial funds.

<u>Section 2:</u> Submitted application and affidavit must be remitted to the Pierce County Clerk's office for one or more members of the Pierce County Board of Commissioners to review before approval is given.

<u>Section 3:</u> That no application for county burial funds be approved when the financial affidavit would indicate that the applicant has more than \$3,500.00 in net worth and has not lived in Pierce County for at least 1 year.

<u>Section 4:</u> That no application for county burial funds be approved when the financial affidavit indicates that the applicant has monthly income which is \$350.00 in excess of monthly expenses.

<u>Section 5:</u> Maximum amount of payment for cremation only services in Pierce County is to be \$3,200.00, such payment is to include cremation fee and all necessary authorizations.

<u>Section 6:</u> This resolution shall take effect after its passage.
