

COMMISSIONERS PROCEEDINGS
August 18, 2025

The Pierce County Board of Commissioners met pursuant to adjournment on Monday, August 18, 2025, at 9:10 A.M. with the following members present: John Steinkraus, Brad Albers and Carl Martinson. Co. Clerk Shannon Wragge, Co. Attorney Ted Lohrberg, Zoning Adm. Heather McWhorter, Deputy Co. Clerk Susan Peters, Co. Assessor Jean Lubke, Co. Treasurer Chris Bahr, Mike Pommer, Dale Clipston, Jim Wachter, Kenny Venteicher, Michelle Reikofski, Brian Moes, Jolene Moes, Jim Schmit and News Reporter Randee Falter were present.

Notice of the meeting was given in advance as shown by the Certificate of Publication on file in the County Clerk’s office. Availability of the agenda was communicated in the advance notice of the meeting. All proceedings shown hereafter were taken while the convened meeting was open to the public. Chairman Martinson called the meeting to order at 9:10 A.M. and presided. Chairman Martinson stated that the Open Meetings Act is posted on the north wall of the board room with more copies available at the County Clerk’s office.

Motion by Steinkraus, seconded by Albers, to approve the agenda. Roll call vote: Aye: Steinkraus, Albers and Martinson. Nay: None. Motion carried.

The minutes of August 4, 2025 were approved as printed.

Discussion was held on levy allocation for the fire districts and agricultural society. The Board stated that since they tried to keep a 3% increase for the County Offices and Road Fund Budgets, they should follow suit with the levy allocations for the Ag Society and Fire Districts. The MFO agreement between the county fire districts states all parties agreed to a levy of .270 mill so therefore that is the max levy the County Board can approve for the fire districts and statute states that rural MFO fire districts need that same levy 1 in 3 years and the first year of the new MFO for the county rural fire districts is 25/26 fiscal year.

WHEREAS, all Fire Districts are given not more than 3.5 cents of the County’s 15 cents for miscellaneous political subdivisions (per \$100 of valuation);

WHEREAS, the Ag Society is to be given not more than 3.5 cents of the County’s 15 cents for miscellaneous political subdivisions and may be given an additional 3.5 cents for capital construction and maintenance of county fairgrounds per Nebraska State Statutes 2-257 and 2-259 (per \$100 of valuation);

NOW, THEREFORE BE IT RESOLVED, by the Pierce County Board of Commissioners/Board of Equalization that the tax allocation for the following subdivision for the 2025-2026 Fiscal Year be limited to .4512 cents for General is approved as follows:

Motion by Albers, seconded by Steinkraus, to Authorize Clerk to advertise and set the county public hearing date for Tuesday, September 2, 2025 at 11:00 a.m. to receive input regarding 2025/2026 fiscal year budget, followed by a second public hearing at 11:15 a.m. for the adoption of property tax at an amount different than prior fiscal year (per SS 148). Roll call vote: Aye: Steinkraus, Albers and Martinson. Nay: None. Motion carried.

Zoning Adm. Heather McWhorter and Jerid Starkel were present and discussion held on the Starkel's Second Subdivision in pt NW ¼ and pt W ½ 1-25-2, 16.37 acres.

Motion by Albers, seconded by Steinkraus, to approve the Starkel's Second Subdivision, a replat of Lot 4 Starkel's Subdivision in pt NW ¼ and pt W ½ of Section 1, Township 25 North, Range 2 West, 16.37 acres. Roll call vote: Aye: Steinkraus, Albers and Martinson. Nay: None. Motion carried.

Hwy Supt. Brian McDonald discussed the Solar Farm Roads and the 1 & 6 Year Rd Plan with the Board. Kenny Venteicher was present and also talked with the Board about the Solar Farm Roads.

Brian & Jolene Moes were present to discuss the road conditions of roads by their farm. Commissioner Albers and Steinkraus were going to look at these roads and intersections.
