## COMMISSIONERS PROCEEDINGS

November 24, 2025

The Pierce County Board of Commissioners met pursuant to adjournment on Monday, November 24, 2025, at 9:10 A.M. with the following members present: John Steinkraus, Brad Albers and Carl Martinson. Co. Clerk Shannon Wragge, Co. Assessor Jean Lubke, Deputy Sheriff Jacob Wostrel, Co. Sheriff Rick Eberhardt, Deputy Sheriff Dan Hallock, Brian Moes, Sue Buckley, Co. Attorney Ted Lohrberg, Clerk of District Court Vickie Prince, Bridge Inspector Randy Stromberg and News Reporter Randee Falter were present.

Notice of the meeting was given in advance as shown by the Certificate of Publication on file in the County Clerk's office. Availability of the agenda was communicated in the advance notice of the meeting. All proceedings hereafter shown were taken while the convened meeting was open to the public. Chairman Martinson called the meeting to order at 9:10 A.M. and presided. Chairman Martinson stated that the Open Meetings Act is posted on the north wall of the board room with more copies available at the County Clerk's office.

Brian Moes was present to discuss road issues he has on 548 Ave between his family farms. He asked the roads to be widened and maintained often. He would also like to see drivers slow down. The County Board asked Moes to clean up all machinery and gates that are within the county right-of-way immediately and no parking machinery or digging on the county roads.
