

COMMISSIONERS PROCEEDINGS  
January 20, 2026

The Pierce County Board of Commissioners met pursuant to adjournment on Tuesday, January 20, 2026, at 9:10 A.M. with the following members present: Brad Albers and Carl Martinson; John Steinkraus was absent. Co. Clerk Shannon Wragge, Zoning Adm. Heather McWhorter, Extension Agent Ann Fenton and News Reporter Randee Falter were present.

Notice of the meeting was given in advance as shown by the Certificate of Publication on file in the County Clerk's office. Availability of the agenda was communicated in the advance notice of the meeting. All proceedings hereafter shown were taken while the convened meeting was open to the public. Chairman Carl Martinson called the meeting to order at 9:10 A.M. and presided. Chairman Carl Martinson stated that the Open Meetings Act is posted on the north wall of the board room with more copies available at the County Clerk's office.
