

BOARD OF EQUALIZATION

July 21, 2025

The Pierce County Board of Equalization met pursuant to adjournment on Monday, July 21, 2025 at 9:00 A.M. with the following members present: John Steinkraus, Brad Albers and Carl Martinson.
